SPIRITUAL ADVISOR:

"Blessed are those who have not seen and have believed."

As hinted in the Gospel readings on Easter Sunday, John, in writing the final pages of his Gospel, had only one definite goal: to define paschal faith, to show how the "eyes of faith" allow the human eye to perceive hidden truths.

However often one has heard it, this last saying of Jesus in John's Gospel, after the accounts of the appearances, can be disconcerting. We have difficulty seeing how it can be so: we have a need to verify things ourselves! Sometimes we would rather subject something to an assortment of tests rather than trust our own eyes. But we also sometimes accept someone's testimony on the basis of their word, having no need to see the thing ourselves. It is not enough to see in order to believe. The apostles, like us, had to go beyond experience to attain faith in the resurrection; and this, we forget all too easily, was not easy for them. They saw Jesus' suffering, his nailing to the cross, death and burial. That this was he, three days later, would hardly have been obvious. Therefore, it would be unjust to suppose that the apostles' faith had no merit.

In order to believe, one must dispense with clear and certain evidence. The testimony of the apostles allows us to partake in their experience as privileged witnesses and believers, attaining, in their wake, the paschal faith that is able to recognize in the man Jesus, "crucified under Pontius Pilate," "the only Son, God, who is at the Father's side" (John 1:16). The story of the double appearance of the risen Lord to the apostles and the finale to John's Gospel has a definite, liturgical, and especially Eucharistic flavor.

"The first day of the week," when the Lord appeared to the apostles, is the day when the Christian community comes together to celebrate the Eucharist, sacrament of the Lord's presence during his absence.

As on the evening of Easter, he brings peace and, with it, forgiveness of sins, joy, and the effusion of the Spirit. The celebration ends with the directive to go out and bring to the world the good news of the resurrection, it witness to it, to show that faith is the source of happiness.

May is also the month to ensure all the requirements for Star Council have been met. Have all the required forms and reports been sent to Supreme? Has your council met their Supreme membership goal? Have your council officers and directors completed the mandatory Safe Environment training available at <u>kofc.org/safe</u>? A great way to end the year would be to win the Star Council award!
